

**Gold Star Coney Jackpot Giveaway
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKES. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, Gold Star Coney Jackpot Giveaway (the "Sweepstakes") is open to participants who are legal residents of the US. Employees of Gold Star Chili, Inc ("Sponsor") and its affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. The term "family members" includes spouses, parents, grandparents, siblings, children, grandchildren and in-laws, regardless of where they live. 7. **Indemnification.** If Sponsor's use of your entry causes Sponsor to be subject to a claim by any third party, you agree to indemnify and hold harmless the Released Parties, and all persons acting by, through, under or in concert with them, against any and all damages, costs, judgments and expenses (including reasonable attorney's fees) which the Released Parties (or any one of them) may incur as a result of the use of your entry.
