Golden Way OFFICIAL RULES

<u>Please note:</u> These Official Rules have been updated to clarify the entry requirements and number of prize drawings. All changes are noted below.

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS CONTEST. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

- 2. <u>Eligibility.</u> Subject to the additional restrictions below, the "Golden Way" Contest (the "Contest") is open to <u>Entrants</u> who are: (i) legal residents of the States of Ohio, Indiana, and Kentucky; and (ii) 18 years or older at the time of entry. Employees of Gold Star Chili, Inc. ("Sponsor"), and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. Entrants must select their favorite chili option ("original" or "vegetarian") on their entry form. There will be two (2) prize drawings: one drawing for all entries selecting "original" chili; and one drawing for all entries selecting "vegetarian" chili.

<u>To be selected as a winner, the potential winners must meet the following requirements: (i)</u> be over the age of eighteen (18) years of age at the time of entry; (ii) be a resident of Ohio, Indiana, or Kentucky; and (iii) be able to meet at a Gold Star Chili location on March 17, 2020.

By participating in the Sweepstakes via Sponsor's website, you agree to be bound by Sponsor's Privacy Policy (<u>http://www.goldstarchili.com/privacy</u>), which is hereby incorporated by reference. Entries submitted in compliance with the foregoing and all other terms in these Official Rules are hereafter referred to as "Entries" or, individually, an "Entry."

Maximum one (1) entry per person and per email address during the Contest Period. The use of multiple identities and/or accounts is prohibited, and any attempt to obtain more than the stated number of entries will void that participant's entries and may result in participant's disqualification. Incomplete, forged, altered, automated, mechanically reproduced, lost, late, misdirected, garbled, or illegible entries, or entries that do not meet the size or formatting requirements specified above, will be disqualified. Sponsor will not be responsible for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender, Sponsor, or Sponsor's Contest application service provider. 6. <u>Winner Notification and Acceptance</u>. The selected entrants will be notified within or about one (1) week after the selection of the winning entrant at the telephone number and/or email provided on the entry form. In order to claim a prize, entrant must respond to Sponsor's notification forty-eight (48) hours of notice or attempted notice.

If Sponsor's use of your entry causes Sponsor to be subject to a claim by any third party, you agree to indemnify and hold harmless the Released Parties, and all persons acting by, through, under or in concert with them, against any and all damages, costs, judgments and expenses (including reasonable attorney's fees) which the Released Parties (or any one of them) may incur as a result of the use of your entry.
